Title: WATER SERVICE MONTHLY RATE SCHEDULE FOR FY 2008/09

WHEREAS, the City of Dayton owns and operates a water system for residents of the City of Dayton; and

WHEREAS, the rates for this service have not been changed since January 1, 2001, by adoption of Resolution #00/01-09, "Establishing New Water Service Monthly Calculation Method and Ascending Rate Schedule and Declaring an Emergency,"

WHEREAS, said resolution outlines the method of calculation of a water service Equivalent Dwelling Unit for a variety of users; and

WHEREAS, said resolution also establishes monthly base rates per EDU and ascending rate structure for users both inside the City Limits and outside; and

WHEREAS, the City has performed a review of its revenue and expenditure needs for the next 5 years in this utility and determined that an annual rate increase must be considered in order to meet the City's obligations to its citizens and the regulatory agencies; and

WHEREAS, a public hearing was duly noticed and held on July 8, 2008, to consider public input on the proposed rate adjustment for the FY 2008/09 year;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Dayton, Oregon:

- 1. THAT the water monthly rate schedule denoted as Option A, as amended, (attached hereto as Exhibit A and by this reference made a part hereof), shall become effective with the billing statement issued for the July, 2008, service; and
- 2. THAT this resolution repeals Section F-2a and F-2b of Resolution #00/01-09; and
- **THAT** this resolution shall take effect immediately upon adoption.
