- 1) THAT the City Council authorizes the 2013-14 Supplemental Budget and appropriates the FY 2013-14 Line Item Adjustments attached hereto as Exhibit A and by this reference made a part hereof; and
- 2) THAT this resolution will be effective immediately upon adoption by the City Council.
