A. CALL TO ORDER & PLEDGE OF ALLEGIANCE

Budget Committee Chair Chris Wytoski called the meeting to order at 6:30 pm and those present gave the Pledge of Allegiance.

B. ROLL CALL

Budget Committee Chair Chris Wytoski noted there was a quorum with Mayor Wytoski and Councilors Collins, Holbrook and Sandoval-Perez, Budget Committee Citizen Members Dahlvig, Gonzalez, Hopper and Mejia in attendance. Budget Chair Wytoski noted the absence of Councilors Mackin, Marquez and Price and Citizen Members Howard and Lien.

Budget Chair Chris Wytoski inquired if there were meeting attendees who would like to make a comment. No attendees were present.

C. DISCUSSION OF PROPOSED 2020/2021 BUDGET

Budget Chair Chris Wytoski reviewed the process for reviewing the budget and City Manager Rochelle Roaden spoke to each fund. The following changes were made to the budget:

- Page 9 adjusted General Fund Revenues from \$738,983 to \$741,983 and Revenue Totals from \$6,841,389 to \$6,844,389. General Fund Expenditures changed from \$738,983 to \$741,983 and adjusted the Expenditures Total from \$6,841,389 to \$6,844,389.
- Page 11 added line item Library COVID Grant for \$3,000-Total General Fund Revenue changed to \$741,983.
- Page 19 added the off-setting Expenditure line item COVID Grant Program under materials and services for \$3,000 Total Library Expenditures changed to \$99,676.

- Page 31 added \$750 to Tourism and Facilities and Promotions line item, Total Materials and Services adjusted to \$2410. Contingency line item decreased by \$750 changing from \$244,953 to \$244,203.
- Page 47 reduced line item Travel-Legislative Economic Development by \$3,000 changing the line item total to \$2,000. Line item Community Giving was increased by \$3,000 changing the line item total to \$10,750.
